### RELEASE AND WAIVER OF LIABILITY AGREEMENT

I understand that during my stay at Somerville Lake House and Cabin, I may be exposed to a variety of hazards and risks, foreseen or unforeseen, which are inherent in hiking, campfires, and other various activities I may participate in here at Somerville Lake House and Cabin.

I know that injuries and damages can occur by natural causes or activities of other persons, animals, or third parties, either as a result of negligence or because of other reasons. I understand that risks of such Injuries and Damages are involved in visiting another place, both indoors and outdoors, and I appreciate that I may have to exercise extra care for my own person and for others around me.

- This agreement is intended to be as broad and inclusive as permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.

-To the fullest extent allowed by law, I agree to, and hereby WAIVE, DISCHARGE ALL CLAIMS, AND RELEASE FROM LIABILITY Somerville Lake House and Cabin, its owners, directors, employees, and agents, from any and all liability on account of, or in any way resulting from, Injuries and Damages, even if caused by the negligence of Somerville Lake House and Cabin, its owners, directors, employees, and agents, and in anyway connected with this facility. I further agree to, and hereby HOLD HARMLESS Somerville Lake House and Cabin, its owners, directors, employees and agents, from any claims, damages, injuries or losses caused by my own negligence while I am guest here. I understand and intend that this assumption of risk and release is binding upon my heirs, executors, administrators, and assigns, and includes any minors accompanying me on my stay at Somerville Lake House and Cabin.

-I understand the cancellation policy is to cancel 10 days prior to my check-in date in order to receive a refund. I shall receive a full refund minus 5% if I charged my deposit on a credit card. This is to pay for the credit card fees. If I do not cancel 10 days prior to my check-in date, then I will be responsible to pay the full amount for my reservation dates.

-I have read this document in its entirety and I freely and voluntarily assume all risks of such Injuries and Damages; and, notwithstanding such risks,

-I also accept responsibility for any damages that occur in my Lake House or for property used by my party while staying at Somerville Lake House and Cabin. I agree to notify the owners if something is broken during my stay and to take care of the property that is used at Somerville Lake House and Cabin. I also understand that my Lake House is inventoried at each cleaning, and any items damaged or stolen will be charged to my credit card unless it was broken or damaged under normal use.
